#### 2. Products and Services

- 2.1 Transformation Storytelling Lab offers the following:
  - Physical products: storytelling board games and printed storytelling diaries
  - Digital products: downloadable diaries (non-refundable)
  - **Services**: online storytelling games, video editing, and podcast production (not covered by return rights)
- 2.2 Physical products are shipped only within the European Union (EU). Orders placed from outside the EU will be canceled and refunded.
- 2.3 All physical products will be delivered within **30 days** of order confirmation, unless otherwise agreed.

#### 3. Right of Withdrawal (Retourrecht)

- 3.1 In accordance with EU and Dutch consumer law, you have the right to withdraw from the purchase of physical products within 14 calendar days of receiving the item, without giving any reason.
